PLEASE NOTE

1. You can cancel this Gift Aid declaration at any time by notifying us in writing.
2. You must pay an amount of income tax and/or capital gains tax, at least equal to the tax that our accountancy team reclaim on your donations in the tax year (currently 25p for each £1 you give).
3. If, in the future, your circumstances change and you no longer pay tax on your income and / or capital gains equal to the tax you can cancel this declaration.
4. If you pay tax at a higher rate, you can claim further tax relief in your Self Assessment tax return.

HOW SEVERN IS FUNDED

As a charity **Severn** is funded entirely by donations from a growing bunch of people who are excited by the vision and want to help make that a reality with their money.

But for many donors, it's more than that - there's this deep passion that everything they have is entrusted to them and provided for them by God. So for many people giving a portion of what he has given them for the purpose of the church is an act of trust and recognition that God is the source of all wealth and opportunities that bring that wealth.

Historically, people in the Bible would use a tenth (where we get the word tithe from) of their annual income as a starting point for their regular giving, but would often add to that with one-off donations for specific purposes. We know that communities where this happened were able to function effectively and the same is true of churches today.

GIFT AID

If you are a UK Taxpayer you can add to your donation by completing a Gift Aid Declaration part of this form. This enables Severn to claim the tax that you have paid on your donation from HMRC (Her Majesty's Revenue and Customs). This equates to 25pence in every pound that you donate! There is no cost to you and simply redirects some of the tax you pay to Severn.

CHARITY ACCOUNTING AND GOVERNANCE

As a registered Charity and Incorporated Company, Severn Vineyard has a board of 5 trustees who bring legal, financial and business management experience into the heart of the charity's organization. Annual Accounts are available from Companies House.

METHODS OF DONATING MONEY TO SEVERN

ONLINE OR TELEPHONE BANKING

If you have access to your bank account, you can set up a regular standing order or single payment to Severn Vineyard using these bank details:

Alternatively, if you would rather our accountancy team contact your bank to set up a Standing Order, please complete the Banker's Order part of this leaflet and pop it in a stamped addressed envelope available on the information desk.

CHEQUES AND CASH

Please make cheques payable to Severn Vineyard Church and pop it into a stamped addressed envelope available from the information desk, or place in the offering basket that is passed around every Sunday at Sunday Gatherings during the mid-service break. This offering basket can be used for cash as well. Please don't use the postal service to donate cash. If you would like to give cash, you might be interested in texting your donation instead.

TEXT YOUR DONATION

If you have a mobile phone, you can donate money to Severn with a simple text service, which is free to you and free to Severn and provided by Vodafone. You do not need to have a Vodafone contract to use the service, it is free on all networks. You can donate the following amounts: £1, £2, £3, £4, £5 or £10 using this service. It's simple - just text **SEVR07 £amount** to 70070. So say you want to donate £25, you need to text "SEVR07 £10" twice and "SEVR07 £5" once. You will receive a text message receipt and if you are using a smartphone you can add Gift Aid to your donation there and then. Unfortunately, the Severn Accountancy team will not be able to acknowledge these donations as Severn does not receive information from Vodafone about the donor, unless you request them to do so. This service may be useful to you if you currently donate cash to Severn.
